

SALES CONDITIONS

General:

- All our prices are EXW.. valid for 90 day, excl. VAT. Also special local taxes on refrigerants & others (if applicable) are excluded
- Payment conditions on the machine: 40% on order, 50% before shipment, 10% after arrival and before installation.
- Shipment time will be around 4 weeks after order confirmation and down payment received. \checkmark
- Please make sure that on arrival the machine (especially the electronical parts & the control cabinet) is shielded against the rain. Best is to make a cover over both machine section and vacuum room!
- On sales, this machine will be supplied with a buy-back guarantee: 70% refund within the first year, 50% refund within the second year. Only valid when the machine has been serviced by us according to schedule (once every season, or twice a year for year round operations).

Payment on rental conditions (as alternative to the buy-back offer we provide):

- 30% (of sales value) down payment on order as one year rental fee. \checkmark
- \checkmark 40% (down payment) on shipment – as deposit.

Within 1 month before the end of the rental period you can decide to:

Return the machine to us; after return you get back the deposit minus damages outside normal usage. \checkmark

A 3% surcharge (on the sales price) is applicable for each rental up to 6 months / one season, for maintenance costs on pumps & system.

- \checkmark Prolong the rental for (one) extra year: For each additional year/season we charge 20% of the purchase price, plus 3% for extended warranty - to be paid in advance.
- Keep the machine, half of the rental fee will be reimbursed: ~

On Installation:

- Machines need to be placed on a flat floor. \checkmark
- ~ Customer is responsible for unloading, placing and connecting (power, water, drain) the system.
- System installation and start-up is excluded. Unloading, placement and connection of piping & cables has to be organized on site.
- Glycol & glycol filling is excluded, if machine at end of rental period is returned, you will receive back 50% of the glycol \checkmark costs (excl. filling).
- For installation & commissioning we send one supervisor to coordinate. We invoice € 600 per day, plus travel & stay. 70% of expected costs before installation, balance within 30 days after start-up / service.

On Warranty:

- We supply the machine with a 3 month warranty (from installation) date on parts & labour cost.
- Warranty is only valid when the machine has been serviced regular maintenance (once every season, or twice a year for year round operations).
- Excluded (at all times) are travel time & costs.

Others:

On all quotations and orders, the general sales conditions of the Metaalunie are valid, unless otherwise specified. These conditions are attached. Chamber of Commerce: 57287376 Rotterdam. Dutch law applies. Disputes will be heard exclusively by the Dutch civil court with jurisdiction over the Contractor's place of establishment, unless this is contrary to mandatory law. The Contractor may deviate from this rule of jurisdiction and apply the statutory rules of jurisdiction.
